Case Competition – This year's case focusses on the 'S' in ESG. It tackles the issue of enhancing EDII in businesses, including academic institutions.



Stock/Company Pitch – Designed to showcase students' finance skills, the stock pitch competition will have students pitching an ESG Stock or an impact investment proposal. This competition will focus on the 'E' and 'G' aspects in ESG.
